Dear neighbors,


It is the honor of my lifetime to represent you in Congress. I came here on a promise to bring mid-Michigan's values, priorities, and sensibility to the nation's capital, and results back home to you. It's no secret that Washington can be a frustrating place, and our politics have never felt more divided, but we don't let that get in the way of fighting for and delivering on what matters most — lower costs and a fair shot for hardworking families. This report includes some key highlights and wins for mid-Michigan from our first year.

First and foremost, we are working hard to bring down costs. From farmers to factory workers to small-business owners, everybody feels the same pinch. We have been fighting wrong-headed policies that are making things worse, including dangerous cuts to health care and food assistance, and reckless tariff taxes that further drive costs up and hurt our farmers. But we know that opposition to further damage is not nearly enough. I have worked with colleagues in both parties to introduce bipartisan bills that will strengthen Social Security and lower key costs, like medicine, child care, and even eggs. We have even had two of our bills signed into law.

At home, my team and I aim to be ever-present in all of our communities and to solve any issues you may have. Just this year, we have returned more than \$9 million (and counting!) to mid-Michigan families and seniors by solving issues with federal agencies like the IRS, VA, and the Social Security; brought home millions in federal dollars for projects that strengthen our communities; and held more than 140 events across mid-Michigan. We even saved the Saginaw Social Security Office from closure and ensured the Flint Registry continues to serve families impacted by the Water Crisis. We are committed to serving you every way possible.

If there's anything our office can assist with, or if you have any thoughts, ideas, or questions, please reach out. As we enter our second year, I am excited to continue working with you on making mid-Michigan more affordable, prosperous, and strong. I hope to see or hear from you soon.



On March 4th, the Saginaw Social Security field office was included on a list of government buildings targeted for closure by the Trump Administration and Elon Musk's DOGE. I immediately sent a letter to the Administration, demanding the office stay open. After the Administration failed to respond for over a month, members of our community hosted a press conference outside the field office and sent a second letter. Finally, after mid-Michigan turned up the pressure, the Trump Administration made a firm commitment that the Saginaw Social Security field office will stay open.



The Flint Registry has been the bedrock for Flint’s response to the Water Crisis – helping track long-term health impacts and connecting affected residents to resources. Earlier this year, funding for the Registry was threatened, so I brought the entire Michigan congressional delegation – Democrats and Republicans – together to write to Congress and President Trump, highlighting the importance of the Registry. We were successful in securing funding through 2026, and we will keep pushing to make sure that Flint families get the help they need for years to come.

Things are far too expensive. I am fighting reckless policies that raise costs and working on commonsense solutions to protect your pocketbooks.

### Bipartisan Bills to Lower Everyday Costs

Every day, I work with colleagues from both parties on commonsense ideas to lower the costs of all kinds of things. For example, we have put forward legislation to:

- **Bring down the cost of eggs.** My *Lowering Egg Prices Act* would lower egg prices for consumers by cutting red tape that forces farmers to discard hundreds of millions of eggs each year.

## Working to Lower Health Insurance Premiums

While Congress has failed to extend the *Affordable Care Act (ACA)* enhanced premium tax credits, families across mid-Michigan have been getting notices that their premiums will rise by hundreds or thousands of dollars per month. I have been working relentlessly to fix it. I continue to work with members of both parties to extend the tax credits and led 36 of my colleagues in demanding a vote. At roundtables in Flint, press conferences in Saginaw, and community discussions in Midland, and from a podium on the steps of the U.S. Capitol, we have lifted up your voices to demand action, and we will keep fighting to get these credits passed and bring down the cost of health care.

## Fighting to Fix Cost-Raising Tariff Taxes

## Defending Social Security

After paying into the system their entire lives, seniors deserve to have their Social Security benefits waiting for them. So when Social Security Administration mispayments put seniors in thousands of dollars of debt through no fault of their own, that's not right. I worked with a Republican from Iowa to introduce the *Social Security Overpayment Relief Act*, which will protect seniors by limiting the mispayment clawback period to 10 years.

## Protecting Veterans Benefits

**When men and women sign up to defend our country, we make a promise to take care of them when they get home.** Too often, we've fallen short of that commitment. One example is how over 50,000 medically retired veterans are forbidden from receiving their full retirement pay and disability compensation. I am working to pass the *Major Richard Star Act* to rectify this injustice and take care of our veterans.



# TAKING ON CORRUPTION

## After one year in Washington, one thing is clear: this place is broken.

The wealthy and well-connected have found ways to rig the system for themselves, and places like mid-Michigan pay the price. In order to actually pass policy that puts working people first, we need to clean up Washington. I put forward a commonsense agenda to get self-dealing out of Washington. Here's what I have been calling for.

## MY ANTI-CORRUPTION AGENDA

**1 Ban Members of Congress from trading stocks:** When members of Congress vote, they should weigh only one thing: what's best for you. But when members from both parties trade stocks — with prices that go up and down based on laws we pass — it's a massive problem. It's time to pass our bipartisan bill to end it.

**2 Get conflicts of interest out of the White House:** President Trump promised to drain the swamp, but since he took office, things have gotten worse. We need to ban conflicts of interest, no matter which party controls the White House — let's start with the *Stop Millionaires Using Service for Kickbacks Act*.

**3 Clean up the Supreme Court:** Recently, U.S. Supreme Court justices have accepted lavish vacations, gifts, and even school tuition for relatives from the well-connected, with business before them. So, when the court rules in their favor, Americans rightly question whether that was for the law or their friends and boosters. Let's pass the *Supreme Court Ethics, Recusal, and Transparency Act* to create a basic code of ethics.

**4 Clamp down on money in our politics:** Billions of unaccountable dollars flood our elections. We need to get the money out of the dark and into public view. Let's pass the *DISCLOSE Act* which shines sunlight on political donations and spending, and takes critical measures to keep foreign money out of our elections.



**We need to get tough on China**, or we risk falling behind. And it's going to take an all-of-the-above approach. Here are three places I have been leaning in:



- **Protect Our Farmland:** If we allow China or other foreign competitors to buy up large swaths of farmland, that puts our national security at risk. I introduced the *FARMLAND Act*, which would protect one of our greatest resources from falling into the hands of enemies.



- **Stop the Flow of Fentanyl:** Synthetic drugs are killing our loved ones. To crack down on the bad actors responsible for fentanyl reaching our streets, I helped pass the *Stop Chinese Fentanyl Act*.



- **Protect Michigan Jobs:** We need to support American workers as we compete for the manufacturing jobs of the 21st century. The microchip supply chain is especially important to mid-Michigan, so I've worked to bring home grant funding for local manufacturers and fought to improve access to critical resources like silicon.

## YOUR STORIES

“Earlier this year, the VA withheld \$16,000 from me over a clerical error on my DD214 form. I drafted a response explaining why they were wrong. With the help of Congresswoman Kristen McDonald Rivet’s office, we successfully appealed to the Army Review Board and got my money. If you’re a local veteran and you need help, please reach out to her office. They will do everything they can to get it taken care of.”

**Ashley from Bay City** was missing months of Social Security Disability payments due to a coding error. After our team took action, she received over \$99,000 in back pay.

“I had a wait of three to four months to get into the dental clinic, and from there it was just time-consuming. After I reached out to the congresswoman’s office, I got into the dental clinic a week later. Don’t give up hope. Contact your local congressman or congresswoman’s office. They can help you.”

**A family from Flint** approached our team after Medicare claimed their grandmother owed \$22,500 from services provided in 2001 after an injury. After our team intervened, Medicare corrected the case and dropped her debt.

“When our facility was unexpectedly blocked from billing Medicare due to a clerical error on our end, we found ourselves stuck in a cycle of delays and unreturned calls. After weeks of trying to resolve the issue with no success, we reached out to Congresswoman Kristen McDonald Rivet’s office. Her team jumped in right away, cutting through the red tape and getting things moving. Thanks to their support, our downtime was minimal, and we were able to continue serving our patients without major disruption. We’re incredibly grateful for their responsiveness, persistence, and genuine willingness to help when we needed it most.”
