A BILL

To amend the Internal Revenue Code of 1986 to increase the amount of the earned income tax credit for parents of young children.

1 *Be it enacted by the Senate and House of Representa-*
2 *tives of the United States of America in Congress assembled,*

3 **SECTION 1. SHORT TITLE.**

4 This Act may be cited as the “Working Parents Tax
5 Relief Act of 2026”.

1 **SEC. 2. INCREASE IN EARNED INCOME TAX CREDIT FOR**
2 **PARENTS OF YOUNG CHILDREN.**

3 (a) IN GENERAL.—Section 32(c) of the Internal Rev-
4 enue Code of 1986 is amended by adding at the end the
5 following new paragraph:

6 “(5) INCREASE IN PERCENTAGES FOR PARENTS
7 OF YOUNG CHILDREN.—

8 “(A) CREDIT PERCENTAGES.—

9 “(i) 1 CHILD.—In the case of an eligi-
10 ble individual with 1 qualifying child, the
11 credit percentage determined under sub-
12 section (b)(1) shall be increased by 42.24
13 percentage points if such qualifying child
14 has not attained age 4.

15 “(ii) 2 OR MORE CHILDREN.—In the
16 case of an eligible individual with 2 or
17 more qualifying children, the credit per-
18 centage determined under subsection
19 (b)(1) shall be increased by 30.07 percent-
20 age points for each of the youngest 3
21 qualifying children of such eligible indi-
22 vidual that has not attained age 4.

23 “(B) PHASEOUT PERCENTAGE.—In the
24 case of an eligible individual with 1 or more
25 qualifying children, the phaseout percentage de-
26 termined under subsection (b)(1) shall be in-

1 creased by 5 percentage points for each of the
2 youngest 3 qualifying children of such eligible
3 individual that has not attained age 4.

4 “(C) MONTHLY PAYMENT.—The Secretary
5 shall establish a program allowing, at the elec-
6 tion of the taxpayer, for making so much of any
7 refund payment owed to a taxpayer by reason
8 of operation of this paragraph in equal monthly
9 increments divided among the remaining
10 months in the taxable year of the taxpayer dur-
11 ing which the amount of such refund is deter-
12 mined.”.

13 (b) EFFECTIVE DATE.—The amendment made by
14 this section shall apply to taxable years beginning after
15 December 31, 2025.
